

## Minutes of the Parks' Committee Meeting held in the Market Chambers, Holsworthy on Wednesday 17<sup>th</sup> November 2021 at 5.45pm

1139. Apologises for Absence.

1140. Declaration of Interests

Cllr. Parker asked Councillors to declare any relevant interests as they arose.

1141. Minutes of last meeting

Cllr. Kenneally proposed that the Minutes of the Parks Committee held on 20<sup>th</sup> October 2021 be signed as a true record. This was seconded by Cllr. Piper and agreed. (Vote: 4 For, 0 Against, 0 Abstentions)

- **1142. Matters Arising.** To consider matters arising from the minutes of the 20<sup>th</sup> October 2021 **Minute 1130** Cllr. Piper requested an update on the strimming the bank. The TC has not yet managed to contact Plandscape.
- 1143. To review the Parks Committee Action Plan (Appendix A).

Cllr. Piper offered to assist with the drinking fountain project; the ATTC will send him the up to-date research.

The TC has contacted one of the ground works companies regarding the path works required in the park, the works required in Badock Gardens and the MUGA but they have not yet responded. Two other local groundwork companies were suggested and the TC will contact these also regarding the works. Cllr. Piper asked if councillors could attend any meetings regarding the paths and other works.

Regarding the drainage in the park, HASP are awaiting a quote and Cllr. Piper will inform the TC once it is received to discuss further.

1144. To discuss and note the Parks' Income and Expenditure and Budget for the year 2021/22.

The Goal posts have arrived, insured and in storage and the grant towards their cost from the Football Foundation has been received. The TC is currently waiting for a cost for the removal of the old ones and the fitting of the new ones. Cllr. Piper and Cllr. Kenneally would like to be present when the goal posts are being fitted.

- **1145. Station Close** to discuss matters relating to Station Close Park and recreational area. Nothing to report
- **1146. Stanhope Park** To discuss matters relating to Stanhope Park.

The TC has contacted two companies to get some initial ideas for the proposed MUGA in the Park. One of the companies has also suggested some ideas for the proposed SEND extension to the existing playground in the park. Cllr. Piper stated the use for the MUGA was for football, tennis and netball amongst others. Cllr. Stone ask what surface would the MUGA have?

After discussion it was agreed that a working group be set up in the new year (as the project is for 2022/2023) to start work on the project and develop the brief. The potential MUGA was discussed in more detail of which the main points to be addressed were the usage, management, S106, lighting, fencing and kickboard.

**1147.** Badock and Rowland Gardens - To discuss matters relating to Badock Gardens and Rowland Gardens.

The TC has arranged for a groundwork contractor to look at the work required for the disabled access improvements for the path will be looking at the Path. Cllr. Parker stated we need to give them our Specifications. TC said there are two companies checking the electricity. Cllr. Parker mentioned Waitrose have expressed an interest in using the sunroom for meetings in the future. Cllr. Piper expressed uncertainty about it being suitable for renting at the current time.
