Cllr. Preston proposed that the Market survey is amended and recommended at full council the be approved. This was seconded by Cllr. Kenneally and agreed. (Unanimous)

1008. To consider the information received regarding the Road Closure for the Market.

Cllr Shepherd read out to councillors the email received from DCC regarding the Road Closure Order which the TC had forwarded to all. Councillors discussed the all-day ban on parking until 6:30pm. The TC clarified that the current TRO is stated on the parking signs within the Square. The TRO is until 6:30pm which councillors discussed as quite late. Therefore, after the advice from DCC, it was suggested that a risk assessment be compiled to consider if the road closure can be lifted early after each market to ensure the road closure isn't negatively affecting residents when the market has been closed and cleared from the road. The TC advised councillors to be aware of any negative actions brought on by members of the public that disagree with the action to comply fully with the DCC advice. Councillors: Preston, Kenneally & Shepherd volunteered to inform shop owners of the decision made by the council.
