

# Minutes of the Parks Committee held In the Town Council Offices on Wednesday 19<sup>th</sup> July 2023 at 6.15pm

**Present:** Councillors: Kenneally, Hosie, Stone, Stroud

In Attendance: Town Clerk (TC), Assistant to the Town Clerk (ATTC)

1347. Apologies for Absence.

Cllrs. De ste Croix, Parker, Piper, Preston

- 1348. In the absence of the Chair Cllr Parker, it was proposed by Cllr. Stroud that Cllr. Hosie be elected Chair of the Committee for the meeting. This was seconded by Cllr. Kenneally and agreed. (Unanimous)
- **1349. Declarations of Interests -** To receive declarations of personal and prejudicial interests in respect of items on this Agenda.
- **1350. Minutes of the Last Meeting** To sign the Minutes of the Parks Committee Meeting held on the 21<sup>st</sup> June 2023

Unfortunately, the minutes could not be signed due to insufficient councillors present.

**1351.** Matters Arising – To consider matters arising from the Minutes of the 19<sup>th</sup> April 2023 Meeting not already covered by the agenda. For information, only.

Not matters arose.

#### 1352. To review the Parks Committee Action Plan (Appendix A)

The Disabled access and improvement work to the Sun Lounge at Badock Gardens has been paused currently whilst Stanhope Park is focused on. The ATTC informed the committee that on 9<sup>th</sup> August the TDC Dog Warden will be attending Holsworthy's Market for dog chip checking and to answer any queries including regarding dog fouling problems. Regarding the Parish Path at Rydon – Cllr Piper has informally spoken to the landowner and states the outcome was positive with a willingness to open the Path and carry out any necessary repairs asap. The Cricket Club and Football Club are looking at possible funding sources from the ECB and Football Foundation to improve the drainage. This drainage works may need to be done before any path improvements in the areas concerned are carried out. It was agreed that the works to install the new street lights should go ahead and that quotes should be obtained for the works to install them.

Regarding the Skatepark Event – Cllr Kenneally is awaiting further response from potential sponsors/ companies to assist with the event. Next meeting dependent on availability to take place on Tuesday 25<sup>th</sup> July at 6pm.

### 1353. To discuss and note the Parks' Income and Expenditure and Budget for the year 2023/24.

The TC noted several key expenditures that have occurred recently. The Grounds Maintenance Contract Invoices have been paid for May & June however, a record is being kept regarding the frequency of cuts completed in the park as the grass has not yet been cut in July. A replacement bin was ordered due to the previous bin located at the Skate Park being vandalised. The TC is also querying the December invoice from the previous ground maintenance company which has not yet been paid due to their work stopping in Mid December and monies still outstanding for damages they caused to a WW1 Memorial Plaque.



- 1354. Station Close to discuss matters relating to Station Close Park and recreational area.

  A member of the public has requested to do graffiti art within Holsworthy. Councillors discussed permitting the artist to create a mural at Station Close. A letter to residents should be drafted to query if they would be on board with this.
- **1355. Stanhope Park/ Skateboard Park** To discuss matters relating to Stanhope Park and the Skateboard Park including the Skateboard Event and the provision of a Youth Shelter.

Youth shelter – Cllr. Kenneally will take a stack of surveys to Holsworthy Community College and the Youth Centre. Cllr. Stone stated it would be preferred if they could go directly to the youth that usually socialise at the Bus stop. The TC suggested social media. Cllr Hosie is concerned about the management of safeguarding. After discussion Cllrs. Stone & Kenneally agreed that by encouraging the youth to be part of the decision made regarding the Youth Shelter it is hoped that they would have respect for the project and take responsibility for the shelter as they will have some ownership toward it. It was also felt that young people should be made aware that vandalism is not tolerated including the history of vandalism of the bin and signs at the Skatepark. It was agreed that the sign that has recently been vandalised at the Skate Park should be replaced.

Cllr. Hosie mentioned that there has been anti-social behaviour beside the Leisure Centre. This has been reported to TDC. Cllr. Stone suggested encouraging residents to form a Neighbourhood Watch and to ask the Police to walk around the park to check on any suspicious behaviour.

**1356. Badock and Rowland Gardens** - To discuss matters relating to Badock Gardens and Rowland Gardens including the commission of a specification for the works required to the Sun Lounge.

There is due to be a Theatre Show in Badock Gardens by Illyria through the Plough Arts Theatre on 12<sup>th</sup> August 2023. HATS will be doing refreshments and have offered their toilets for performers and attendees. If any Councillors are free on the 12<sup>th</sup> their help would be welcome It was suggested that a gate is to be put on the alley to Badock Gardens however, after discussion this was not agreed as it was felt that unrestricted access to the Gardens is preferable.
