GUIDANCE NOTES

Members of the public are required by law to declare interests when they become a Councillor or non-elected Member. These interests include the name of their employer, the addresses of any land within the area of the Council in which the Councillor/Non elected Member has a beneficial interest, or a licence to occupy; interests in companies and securities in which they have substantial interests which operate in the district and other financial interests.

As well as their own interests, the interests of their spouse or partner or the person with whom they live as a spouse or partner must also be declared. If you do not know the interests of your spouse or partner, please mark the form "Not Known".
